



## **DMPs and Internally Funded Projects**

### Research Data Management



**Research Data** is an integral part of all research and scholarly work, hence proper management of such data is widely recognised as an essential area in the responsible conduct of research. [+Read more]

A Data Management Plan (DMP), as outlined in the <a href="NTU Research Data">NTU Research Data</a>
<a href="Policy">Policy</a>, records the intention on how research data arising from the research project will be managed, used and shared. This was started in NTU in Apr 2016, and was only submitted by PIs of externally-funded projects prior to the start of projects.

From 1 Jun 2018, this will be rolled out for internally-funded research projects as well. Pls of these projects will prompted to file a DMP through the Research Information System (RIMS), prior to account creation on the Nanyang Online Research Administration (NORA) system.

### **Expedited Review for NTU IRB**



Due to changes in various processes within NTU IRB, the turnaround time taken to review and approve ethics applications saw an improvement of ~35% in 2017 compared to the previous work year in 2016.

In order to further reduce this turnaround time for PIs, NTU IRB will be processing new Expedited category applications at the <u>start of every week</u>, starting from May 2018. Applications that require Full Board review will still be tabled for discussion as per <u>IRB meeting schedule</u>. Applications need to be properly endorsed on NORA before they can be processed for reviews.
