## SkillsFuture Singapore (SSG) Funding for Certificable Courses\*

<sup>1</sup> **50% SSG (SkillsFuture Baseline Funding):** 50% course fees funding for SCs and PRs aged ≥21 years.

<sup>2</sup> **70% MCES (SkillsFuture Mid-career Enhanced Subsidy):** An additional 20% subsidy for SCs aged ≥40 years (total 70%), regardless of employment status.

<sup>3</sup> **70% ETSS (SkillsFuture Enhanced Training Support for SMEs):** Up to 70% subsidy for SME sponsoring SCs or PRs. Absentee Payroll Funding is standardised at \$4.50/hour, capped at \$100,000/year.

Proof of citizenship status or relevant documents is required for verification.

### \*SSG Funding Eligibility Criteria:

- First-time attempt at the course with funding
- Complete the post-course assessment (BCT) within 2 months of the course completion date
- Participate in the post-course survey
- Must not be full-time National Servicemen
- For company-sponsored participants must be full-time employees during the course and at the time of grant disbursement, with the course fees fully funded by their employer.

### Note:

Inform CI-NTU of any changes in nationality or employment status during the course.

Failure to meet the above criteria may result in a penalty fee equivalent to the SSG Funding amount received.
