	The nominee must have demonstrated significant involvement in research studies or projects during their undergraduate medical education. This includes but is not limited to designing and conducting experiments, collecting and analysing data, and contributing to research publications or presentations.  i. Detailed description of the research projects or studies involved in and their roles and responsibilities within each project.  ii. Letters of recommendation from research supervisors or mentors attesting to the nominee's contributions.
2	Integration with Academic and Clinical Training
	The nominee should demonstrate an ability to balance research activities with their academic and/or clinical training, showing how research has been integrated into their overall medical education and future career planning.  i. Nominee should submit a personal statement on how research experiences have influenced academic and career goals.  ii. Feedback from academic or clinical supervisors on the nominee's ability to integrate research with educational responsibilities.
3	Innovation and Impact in Research
	The nominee's research should demonstrate innovation and have a measurable impact on the field of medicine or healthcare. This can include novel research approaches, significant discoveries, or contributions that have led to advancements in medical knowledge or practice.  i. Description of innovative aspects of the nominee's research.  ii. Examples of the impact or application of research findings.  iii. Testimonials from experts in the field on the significance of the nominee's work.
